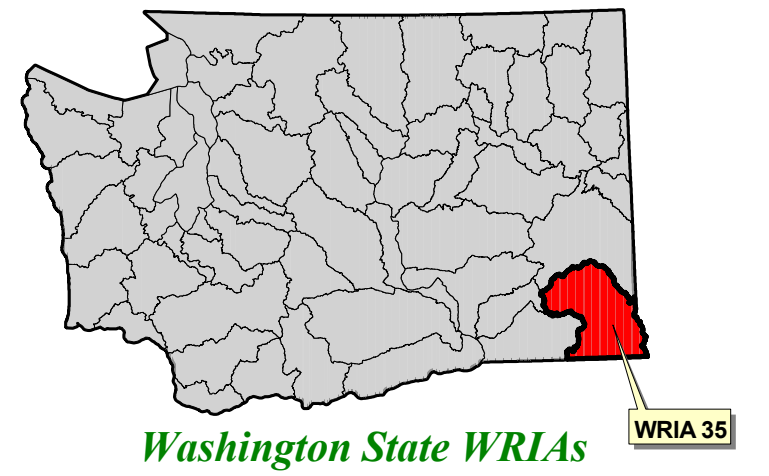
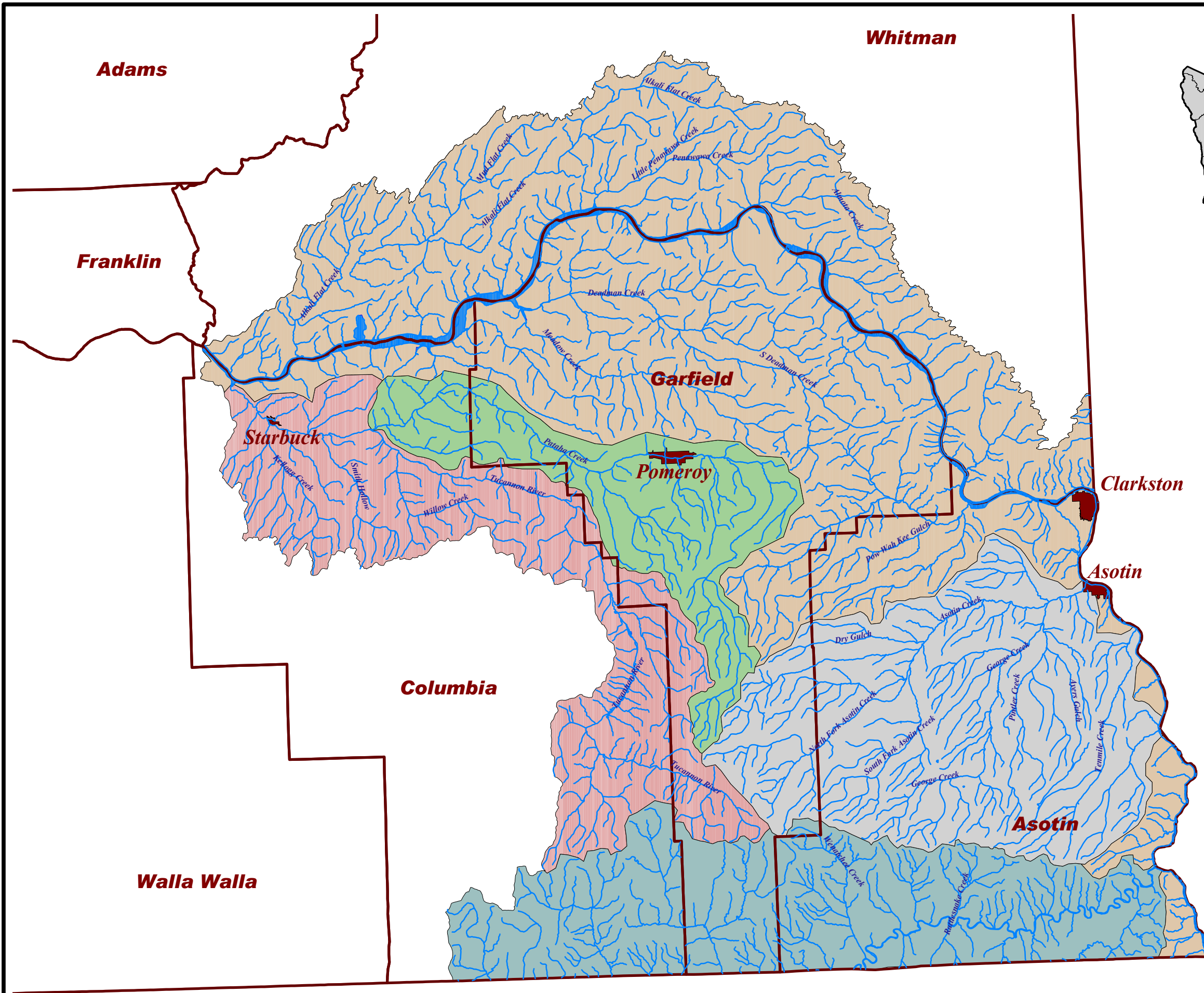
WRIA 35 Location Map

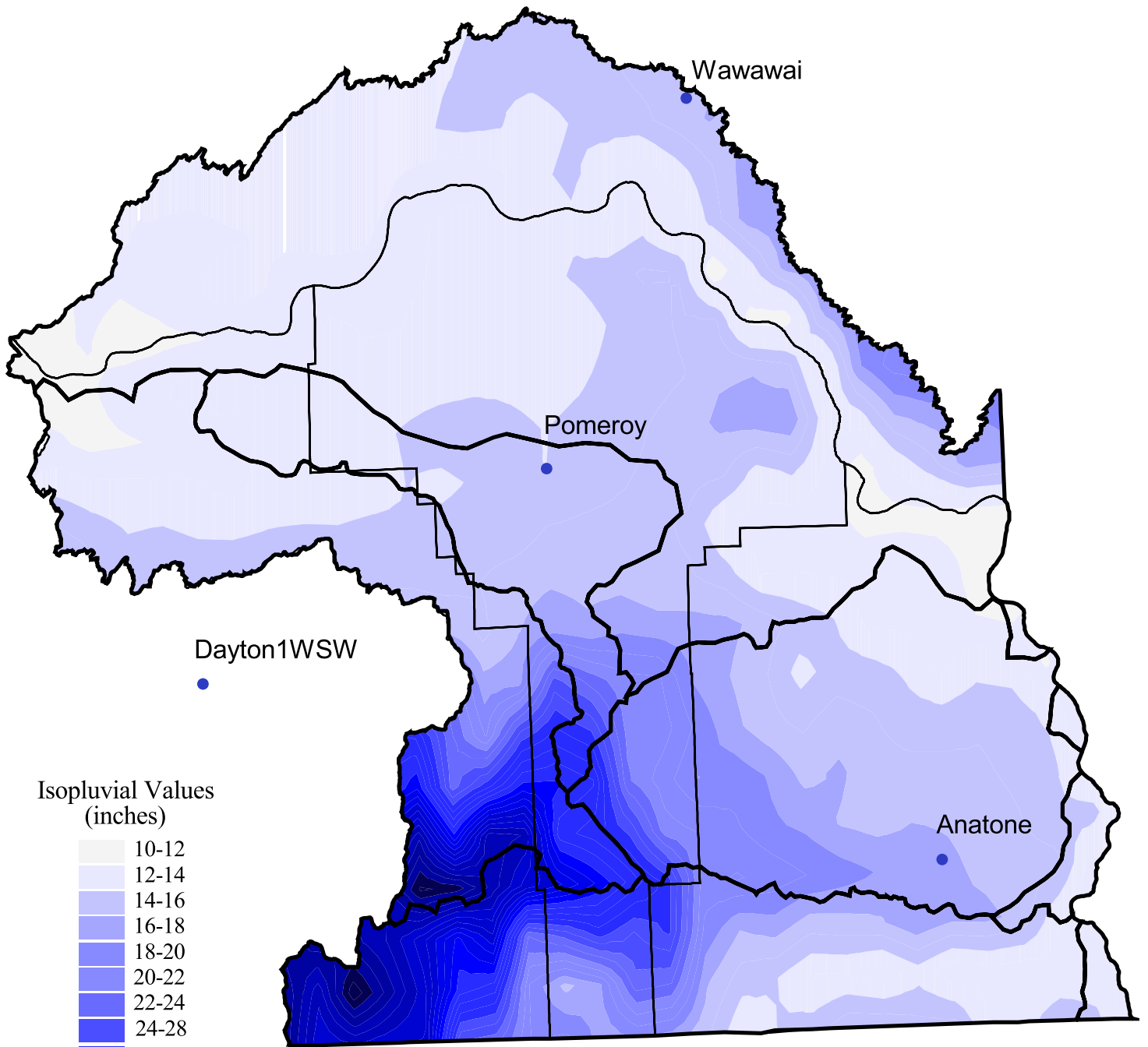

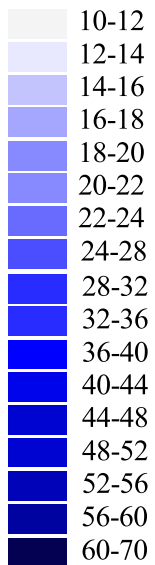



-  Selected Gauges

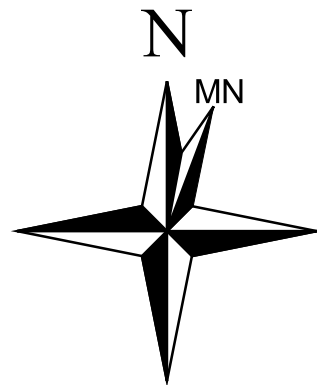

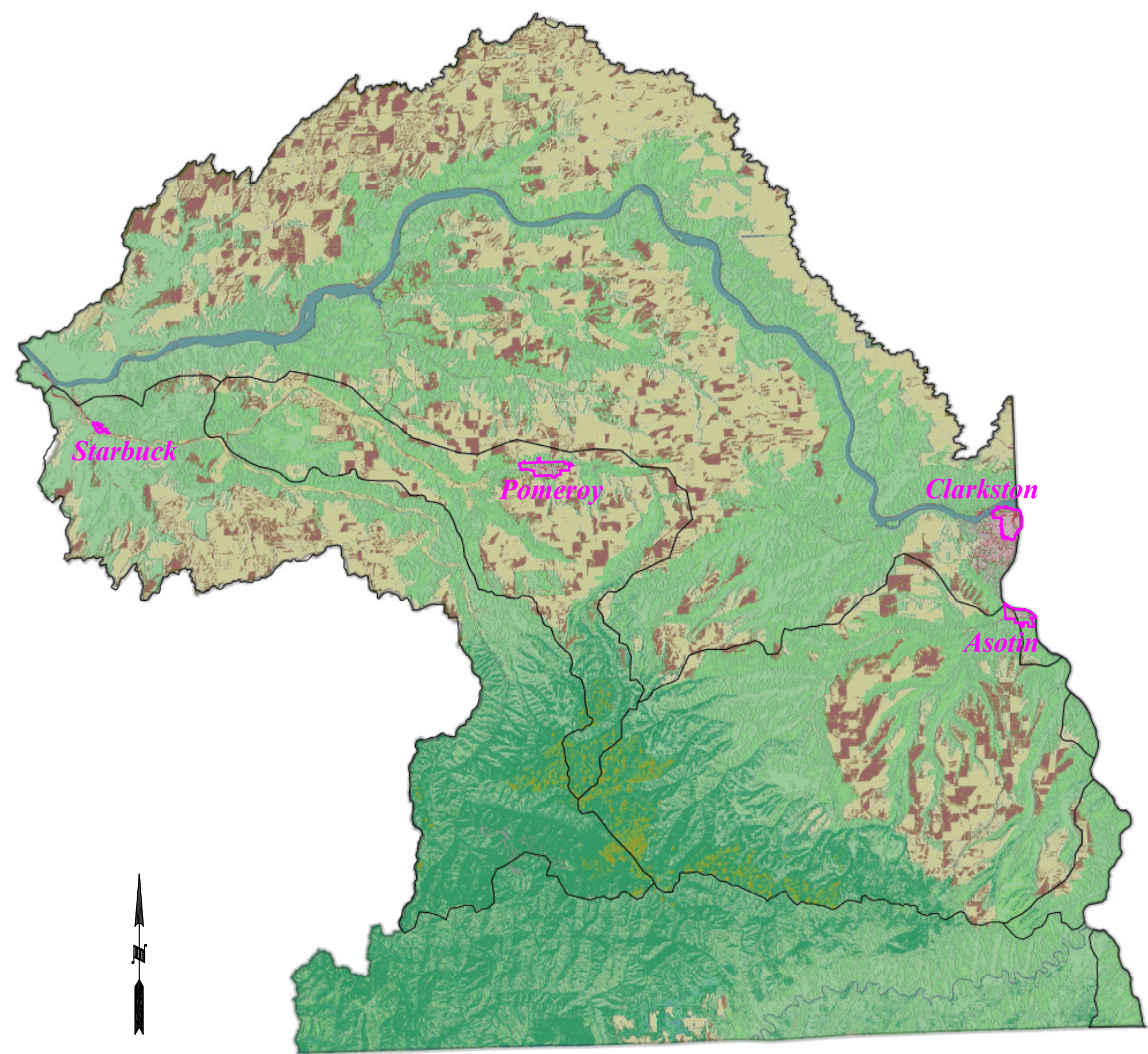

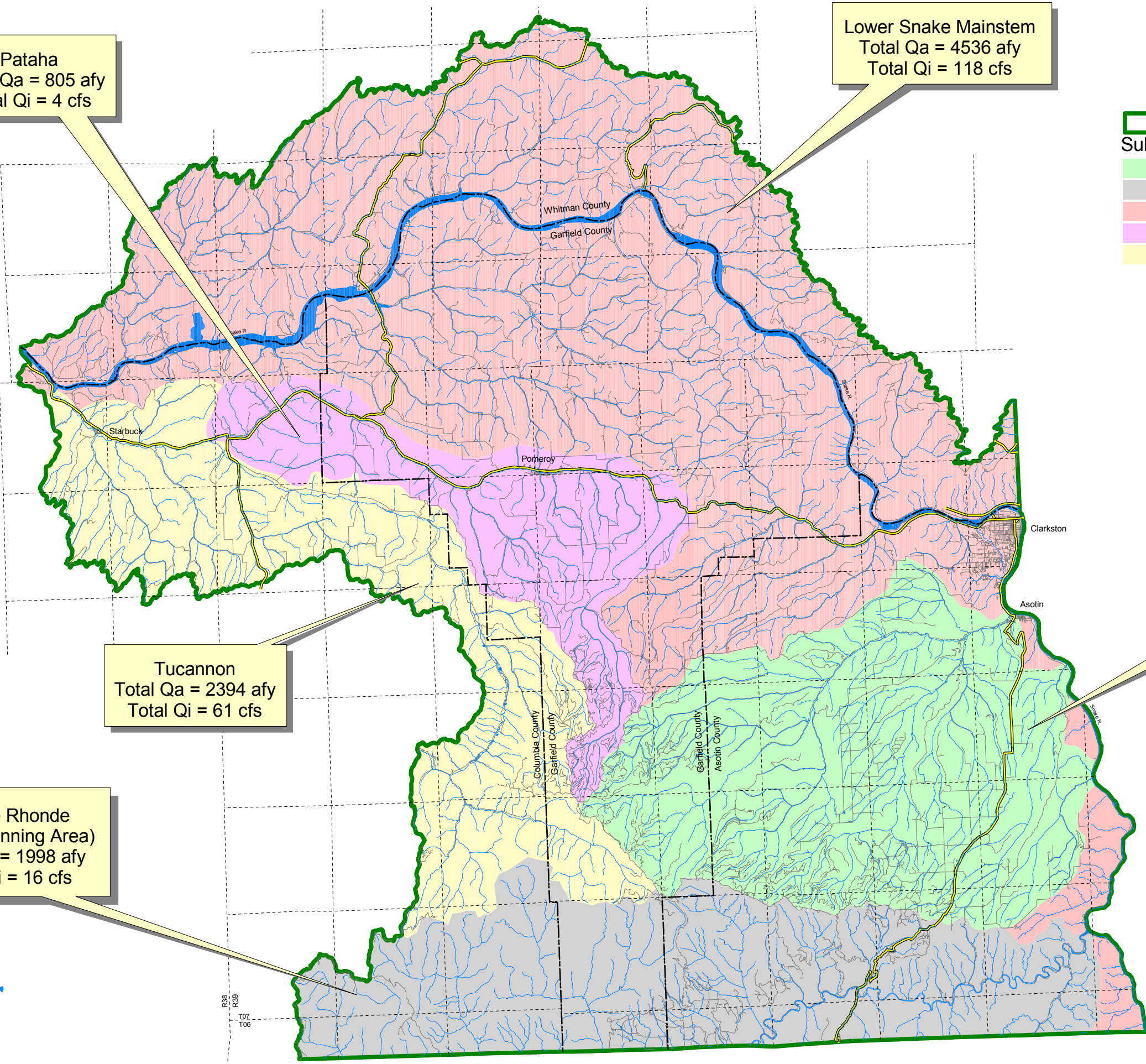

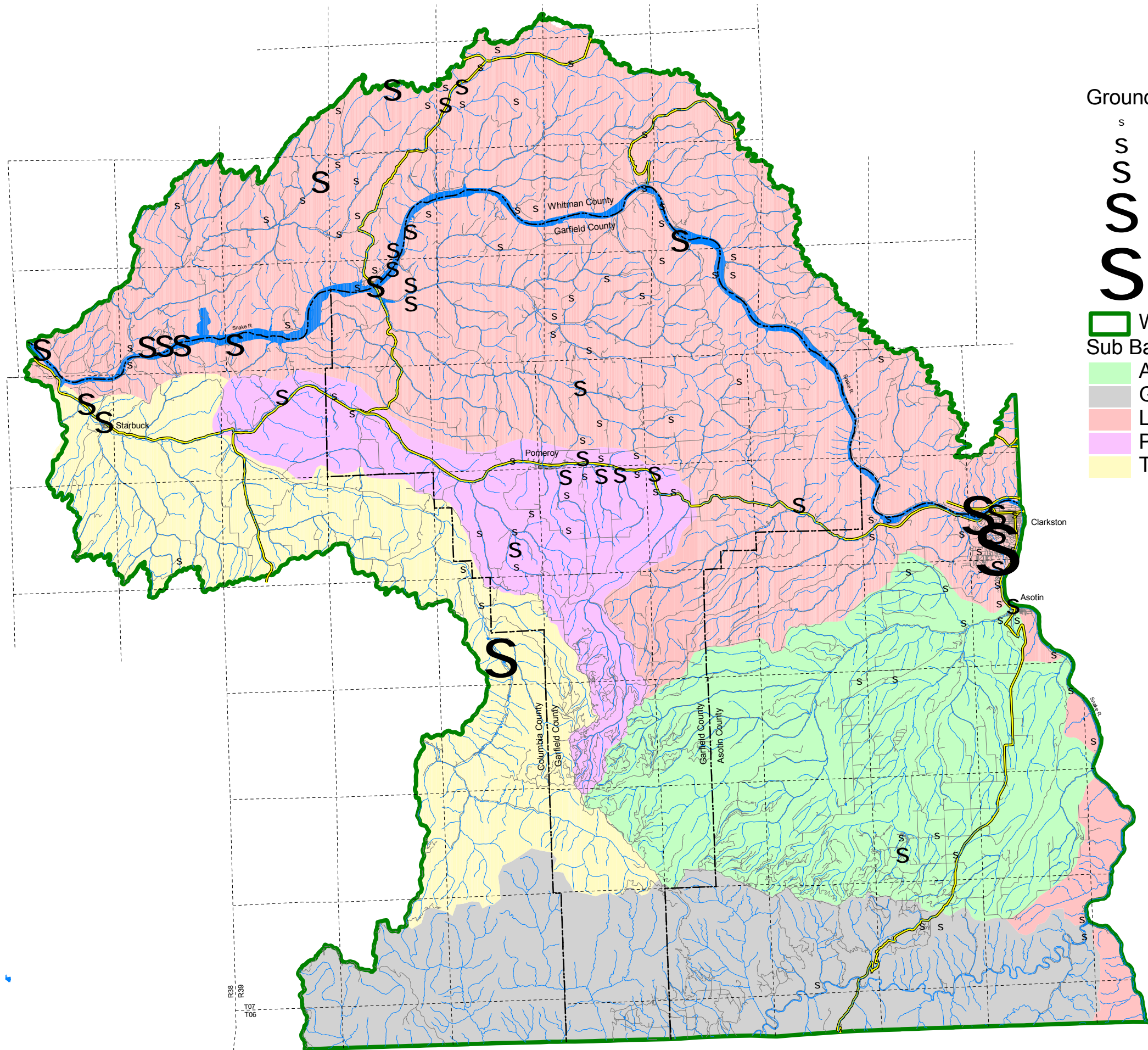
