

ASOTIN COUNTY PUD
WATER SERVICE
RATES, CHARGES and FEES
EFFECTIVE MARCH 1, 2018

SECTION I

It is hereby established for water services furnished by the PUD within its' service area, the following monthly minimum charge, water rate and monthly fire protection service charge. These rates and charges will be subject to a state utility tax at the current rate of 5.029% multiplied by and added to the total of all rates and charges for services provided:

*The Fee shown represents the minimum amount to be charged. Additional fees may be assessed dependent upon soil conditions, service location and other service installation related factors.
