MANAGER'S REPORT

Operations Activity – the manager reported that the crew continues the replacement of service lines identified as having a potential lead pig tail, which is typically 12 to 18 inches long. To date, 71 of the 159 identified services have been replaced with only 11 lead pigtails having been found. Work on current and planned commercial projects was discussed.

<u>2017 Fiscal Year Audit</u> – the manager reported that the State Auditor was onsite today to start the 2017 Fiscal Year Audit. An Audit Entrance Conference will be held on Monday, October 1, 2018. Commissioner Nuxoll will attend the meeting.

<u>MUNIS Conversion</u> – the manager and Treasurer discussed the state of the process with conversion of our customer information system from EDEN to MUNIS. The go-live for MUNIS is planned for November. Budget billing customers will be reconciled by the end of the month in anticipation of the conversion and then re-established January 1, 2019. Customers who pay by credit card will receive a notice soon that they will have to setup a new payment account as part of the conversion.

COMMISSIONER'S REPORT

Commissioner McCall attended the Washington PUD Association's tour of Franklin PUD's Solar Installation and the Commissioner Education and Roundtable that followed the tour on September 12, 2018 in Pasco, Washington. He reported on the energy conservation and solar projects in use at Franklin PUD at their office and in their parking lot. He stated that at the education roundtable Snohomish PUDs battery energy project was discussed detailing their struggles with the Vanadium battery. The Black Rock water energy storage project was also discussed.

Commissioner Ridge and Commissioner McCall will be attending the Washington PUD Association Water Workshop on September 26-28 in Suquamish, Washington in the Kitsap PUD service territory.

Commissioner Ridge will be attending the Public Power Council meetings October 3-4 in Portland.
