

**ASOTIN COUNTY PUD
SEWER SERVICE
RATES, CHARGES and FEES
EFFECTIVE JANUARY 1, 2013**

SECTION I

It is hereby established for sewer services furnished by the District within its' service area, the following monthly sewer charges. Monthly Charges will be subject to a state utility tax at the current rate of 3.852% multiplied by and added to the total of all charges for services provided:
