ABOUT THE AUDIT

This report contains the results of our independent accountability audit of Public Utility District No. 1 of Asotin County from January 1, 2010 through December 31, 2010.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Billings/receivables
- Small and attractive assets such as computers
- Contracts/agreements
- Disbursements/expenditures
- Conflict of interest/ethics laws
- Open public meetings/records laws

RESULTS

In the areas we examined, the District's internal controls were adequate to safeguard public assets. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

ABOUT THE DISTRICT

The Public Utility District No. 1 of Asotin County provides water, electrical, and sewer services to approximately 7,000 customers in Asotin County. The District took over sewer services from Asotin County in January 2010.

An elected, three-member Board of Commissioners governs the District. The Board appoints a General Manager to oversee the District's daily operations as well as its 13 employees. In fiscal year 2010, the District had an annual operation budget of approximately \$3.5 million.
