

**ASOTIN COUNTY PUD
SEWER SERVICE
RATES, CHARGES and FEES
EFFECTIVE JANUARY 1, 2026**

SECTION I

It is hereby established for sewer services furnished by the District within its' unincorporated service area, the following monthly sewer charges. Monthly Charges will be subject to a state utility tax at the current rate of 3.852% multiplied by and added to the total of all charges for services provided:

MONTHLY CHARGE

Single Family Residential and Commercial	\$ 46.00
Qualified Senior Citizens and Disabled Persons	\$ 37.50
Port of Wilma	\$ 75.00

In addition to the Monthly Charge, Single Family Residential, Commercial and Port of Wilma customers will be charged additional monthly fees based upon the Equivalent Residential Unit designation listed in the User Classification Schedule in Section IV.

SECTION II

It is hereby established for sewer services furnished by the PUD, within the incorporated City of Clarkston service area, the following Monthly Sewer Charges:

1. The Monthly Sewer Charge will be based on a two-month average of water consumed for the months of January and February of the previous year.
2. Total Monthly Charges include a state utility tax at the current rate of 3.852%.
3. Green houses and accounts not connected to the PUD water system will be billed at the Monthly Base Charge plus the Average Monthly Water Consumption for their Classification. The average monthly residential water consumption is 6.50 units and the average commercial water consumption is 20 units.
4. Automatic car washes will be charged three (3) times the Commercial Average Monthly Rate.

SECTION III

SEWER CONNECTION FEES

A Sewer Connection Fee will be assessed for each dwelling or commercial building that will be connected to the District Sewer System and a System Development Fee will also be assessed per Equivalent Residential Unit (ERU) as identified in the User Classification Schedule in Section IV.

Any commercial, industrial, residential or multi-family dwelling that requests sewer service shall pay the following fees in order to connect the District Sewer System:

System Development Fee per ERU	\$ 400.00
